As these are seasonal activities, all dates are weather dependent. Mountain biking will be closed once the resort begins making snow. The golf course closes October 31, 2023 for the season.

Golf: All memberships are non-transferable. Membership includes unlimited greens fee with a cart. Must make tee time with pro shop. Any member may have their membership revoked or suspended or may be asked to leave the premises for any of the following but not limited to; physical or verbal abuse, destruction of club property, commission of lewd or unlawful activity of the grounds, violation of club policies or rules or conduct that detracts from managements right to manage the facility and preserve the integrity of Alpine Valley Resort.

Ski/Snowboard: Rules: 1. **NO REFUNDS. ALL SALES FINAL.** 2. NO LIFT TICKETS will be AVAILABLE without additional charge, DO NOT LEAVE YOUR PASS AT HOME!!!! 3. \$75.00 Replacement Fee for lost or stolen passes. 4. Reselling, Exchanging, Lending or Obtaining passes under false terms will result in immediate loss of pass and all privileges without refund. 5. Season Passes must be clearly visible at all times. 6. Pass holders must heed all signs and follow all rules posted or otherwise implied by the Ski Area and Skier Responsibility Code.

DO NOT SIGN THIS AGREEMENT UNTIL YOU HAVE READ THE SAME AND FULLY UNDERSTAND IT.

I understand and accept that downhill skiing and/or snowboarding in its various forms, is an inherently hazardous and dangerous activity. Such activities include many risks including the risk of serious injury and death. I freely and knowingly accept and voluntarily assume all risk of property damage, personal injury and death to me while on the premises of the ski area.

I hereby expressly release from liability the ski area, it's agents, employees, directors, officers, shareholders, ski patrollers, ski instructors, affiliates, partners, corporations, associations and the like from any and all claims, actions, causes or actions demands, rights, damages, costs, loss of services, expenses and compensation whatsoever which the undersigned now has or which may hereafter accrue on account of any foreseen or unforeseen bodily injuries and/or damages.

I represent and warrant that this release extends to my heirs, executors, administrators, successors, spouse, dependents, children and assigns and I hereby freely and voluntarily acquit and forever discharge any cause of action for the consideration of a reduced charge for a season ski pass and access to the ski area for an entire ski season.

The undersigned further agrees for and on behalf of any minor who is involved in obtaining this season ski pass and/or any of the services of the resort that the undersigned parent, adult, guardian, supervisor, and/or conservator agrees to indemnify and hold harmless the ski area, the ski school, any of its instructors, agents, administrators, employees, firms, servants, corporations, affiliates, partnerships and the like from and for any and all damages, legal fees or expenses, fees and costs, rights, causes of action, losses, claims and actions which may, do or shall arise or grow out of any know or unknown injuries and/or damages which occur as a result of engaging these services and/or while participating in activity on the premises of the ski area.

WARNING – ASSUMPTION OF RISK. Under Wisconsin law, each participant in a snow sport assumes the risk of injury or death to person or injury to property resulting from the conditions and risks that are considered to be inherent in an alpine sport, has a number of duties that must be met while engaging in an alpine sport and is subject to limitations on the ability to recover damages from a ski area operator for injuries or death to a person or to property. A complete copy of this law is available for review at the main site where tickets to the ski area are sold.

Golf Cart Liability

In exchange for the privilege to rent this golf cart, you are accepting responsibility for your own negligence. You must operate this vehicle in a safe manner, and adhere to all rules set forth by Alpine Valley Resort. You are liable for all medical and legal claims that may arise from rental of the golf cart. You voluntarily agree to accept the risks of using a golf cart and on behalf of yourself, your personal representatives and your heirs hereby voluntarily release the aforementioned business, and its owners, officers, employees, and agents from any and all claims, actions, causes of actions, suits, judgments and demands for bodily injury, property damage, loss of life and/or loss of services, in law or equity, that may in any way or manner arise out of use of the golf cart.

You must be at least 16 years of age and show a valid driver license to rent a golf cart. Under no conditions are you allowed to let another driver drive this vehicle, unless cleared by the staff upon signing of this waiver.

Cart must remain on Alpine Valley Resort property. Please stay on cart paths and designated areas at all times. Do not take cart on nature trails, native grass areas, etc

Maximum of 2 people on cart and all passengers must be seated. NO CHILDREN ALLOWED IN DRIVERS LAP.

Cart must be parked & key returned to staff by sundown.

Anyone observed abusing golf cart rules and regulations will forfeit all rental privileges immediately. This includes reckless driving, speeding, bumping or allowing underage guests to operate the cart.

You agree to pay for any damage to the Cart & authorize us to charge your credit card for same.

You further agree to pay for any costs we incur to collect for damages.

A charge of \$50.00 will be given to each golfer renting AV Cart that run out of battery after 18 holes or after leaving the course (other than stops to any of Café's /Pro Shop).

It is strictly forbidden that a minor or any individual without a valid driver's license operate this vehicle. At no time may a minor have a hand or hands on the steering wheel when the vehicle is moving. This requires you to have possession/control of vehicle keys when not in use. Golf carts are a motorized vehicle and driving or riding in these vehicles can lead to serious injury, property damage and even death. No excessive speed, joy riding, or any type of unreasonable activity with the golf cart will be tolerated. You must not attempt to transport more people than the cart was designed for. In no way should the renting of this vehicle be seen as Alpine Valley Resort endorsing this vehicle as a form of recreation or fun. If the management of the course determines in it's sole discretion that you have misused the golf cart in any way, it will require an immediate return without a refund. WE DO NOT GIVE WARNINGS. WE WILL TAKE YOUR GOLF CART! Don't risk your hard-earned money by violating these rules!!!

Golf carts are for the use of golfing ONLY. Alpine Valley Resort DOES NOT consent to ANY other use of a golf cart other than for the purpose of golfing on the course. Alpine Valley Resort DOES NOT consent to the use of the golf carts for the purpose of joyriding, sight-seeing, leaving the golf course or the property of Alpine Valley Resort. This includes taking a golf cart to Alpine Valley Music Theater as it IS NOT owned or operated by Alpine Valley Resort.

Anyone who uses a golf cart for purposes other than golfing will be considered as operating without owners consent per Wisconsin State Statute ss 943.23(2) as well as civil liabilities.

If any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect. Lessee acknowledges receipt of equipment below which is found by Lessee to be in working condition w/ noted exceptions I HAVE CAREFULLY READ, UNDERSTAND AND VOLUNTARILY AGREE TO THE TERMS ABOVE.

ACTIVITY RELEASE OF LIABILITY READ CAREFULLY - THIS AFFECTS YOUR LEGAL RIGHTS

In exchange for participation in the activity of mountain biking or hiking organized by Alpine Valley Resort ("Alpine") of W2501 Hwy D, Elkhorn, WI 53121 and use of the property, facilities and services of Alpine Valley Resort, I, _____, agree for myself and (if applicable) for the members of my family, the following:

1. I agree to observe and obey all posted rules and warnings, and further agree to any oral instruction or directions given by Alpine, or the employees, representatives or agents of Alpine Valley Resort
2. I recognize that there are certain inherent risks associated with the above-described activity and I assume full responsibility for personal injury to myself and family members, and further release and discharge Alpine Valley Resort for injury, loss or damage arising out of my or my family's use of or presence upon the facilities of Alpine Valley Resort, whether caused by the fault of myself, my family, Alpine Valley Resort or other third parties.
3. I agree to indemnify and defend Alpine Valley Resort against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation cost, which may in any way arise from my or my family's use of or presence upon the facilities of Alpine Valley Resort.
4. I agree to pay for all damages to the facilities of Alpine Valley Resort caused by my or my family's negligent, reckless, or willful actions.
5. Any legal or equitable claim that may arise from participation in the above shall be resolved under Wisconsin law.
6. I agree and acknowledge that I am under no pressure or duress to sign this Agreement and that I have been given a reasonable opportunity to review this before signing, I further agree and acknowledge that I am free to my own legal counsel review this Agreement if I so desire. I further agree and acknowledge that Alpine Valley Resort has offered to refund any fees I have paid to use its facilities if I choose not to sign the Agreement.
7. This Agreement and each of its terms is the product of an arms' length negotiation between the parties. In the event any ambiguity is found to exist in the interpretation of this Agreement, or any of its provisions, the Parties, and each of them, explicitly reject the application of any legal or equitable rule of interpretation which lead to a construction either "for" or "against" a particular party based upon their status as the drafter of a specific term, language, or provision giving rise to such ambiguity.
8. The invalidity or unenforceability of any provision of the Agreement, whether standing alone or as applied to a particular occurrence or circumstance, shall not affect the validity or enforceability of any other provision of the Agreement or any other applications of such provision, as the case may be, and such invalid or unenforceable provision shall be deemed not to be part of this Agreement.
9. Any controversy or claim arising out of or relating to this contract, or breach thereof, shall be settled by arbitration administered by the American Arbitration Association in accordance with its Commercial Arbitration Rules, and judgment on the award by the arbitrator(s) may be entered in any court having jurisdiction thereof.
